

ORDINANCE NO. 2012-1

AN ORDINANCE AMENDING ORDINANCE NO. 2011-16, ADOPTED MAY 10, 2011, RELATING TO EXHIBIT A, POSITION AND SALARY SCHEDULE AS IN CODIFIED ORDINANCE §161.04(a) AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

Section 1. Codified Ordinance 161.04 (a) is hereby amended to read as follows:


“161.04 POSITION AND SALARY SCHEDULE

(a) The position and salary schedule, marked Exhibit “A”, which is attached hereto and made a part of this Code shall be effective as of “January 24, 2012.”


Section 2. Codified Ordinance Section 161.04 (a) as existing prior to the adoption of this Ordinance shall be, and the same hereby is, repealed.

Section 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including R.C. 121.22.

Section 4. To insure the continued service of City employees without interruption, this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and general welfare; **wherefore**, this Ordinance shall be in full force and effect from and immediately after its passage.
